This Privacy Policy explains how ForgdHQ Inc. ("Company," "we," "us," or "our") collects, uses, stores, shares, and protects information when you use our websites, applications, products, software, and related services (collectively, the "Services").

1. Information We Collect

We may collect the following categories of information:

Information You Provide

- name, username, and profile information;
- email address and login credentials;
- messages, posts, comments, uploads, and other content you submit;
- payment and subscription information;
- communications you send to us.

Automatically Collected Information

- IP address;
- device information;
- browser type and operating system;
- usage activity and analytics;
- cookies and similar technologies;
- log data and diagnostic information.

2. How We Use Information

We may use information to:

- provide, operate, maintain, and improve the Services;
- authenticate users and secure accounts;
- process subscriptions and payments;
- communicate with users;
- detect fraud, abuse, spam, security incidents, or illegal activity;
- personalize user experience and platform functionality;
- comply with legal obligations;
- enforce our Terms of Service.

3. Sharing of Information

We may share information with:

- service providers, vendors, hosting providers, analytics providers, and payment processors;
- legal authorities where required by law or to protect rights and safety;
- affiliates or successors in connection with mergers, acquisitions, financing, or asset sales.

We do not sell personal information for monetary compensation.

4. User Content

Content you post publicly through the Services may be visible to other users and may be copied, shared, or redistributed by others.

We are not responsible for how other users use or share publicly available content.

5. Cookies and Analytics

We may use cookies, analytics tools, and similar technologies to:

- remember user preferences;
- analyze platform usage;

- maintain security and authentication.

You may disable cookies through your browser settings, though some features may not function properly.

6. Data Retention

We retain information for as long as reasonably necessary to:

- provide the Services;
- comply with legal obligations;
- resolve disputes;
- enforce agreements;
- maintain security and operational integrity.

We may retain certain information after account deletion where legally permitted or required.

7. Security

We implement reasonable safeguards intended to protect information from unauthorized access, disclosure, misuse, or destruction.

However, no method of internet transmission or electronic storage is completely secure, and we cannot guarantee absolute security.

8. Age Restrictions

The Services are intended only for users who are at least 16 years old.

We do not knowingly collect personal information from individuals under 16. If we become aware that information has been collected from a person under 16, we may delete the information and terminate the associated account.

9. California Privacy Rights (CCPA)
